Lesi Senezelo Sokucutshungulwa Kwedatha (\("i-DPA"\)) yisenezelo Sesivumelwano se-The Lincoln Electric Company End-User License \("\EULA"\) futhi sisebenza phakathi kwe-The Lincoln Electric Company (\("\Umcubunguli Wedatha\") kanye nomshisekeli Ongumsebenzisi Ogunyaziwe we-EULA ("Umlawuli Wedatha"), (ngamunye "\Iqembu\", bese ndawonye "\Amaqembu\").

KUYILAPHO

I-EULA ilawula ilungelo Lomsebenzisi Ogunyaziwe ukusebenzisa Isicelo Esinelayisense futhi, njengoba kusebenza, namanye amasevisi aku-inthanethi anikezwa yi-The Lincoln Electric Company. Ngenhloso yokwanelisa izibopho zayo ngaphansi kwe-EULA, i-Lincoln Electric Company izosebenza Njengomcubunguli Wedatha egameni Lomsebenzisi Ogunyaziwe. Ukuze kuqinisekiswe ukuthobela imithetho Yedatha Yomuntu Siqu, Amaqembu avumile ukwengeza i-EULA ukuze asethe imigomo nemibandela esebeenzayo Ekucutshungulweni Kwedatha Yomuntu Siqu Yisicubunguli Sedatha egameni Lomlawuli Wedatha.

1. IZINCAZELO

1.1 Kule DPA, imigomo enosonhlamvukazi iyoba nezincazelo ezilandelayo, ngaphandle kwalapho kuchazwe ku-EULA noma lapho kudingeka ukuba kunikezwe umongo ngenye indlela:

"Umlawuli Wedatha" usho ibhizinisi elinquma izinhloso nezindlela Zokucutshungulwa Kwedatha Yomuntu Siqu;

"Umcubunguli Wedatha" usho ibhizinisi elicubungula Idatha Yomuntu Siqu egameni Lomlawuli Wedatha;

"Umnikazi Wedatha" usho umuntu okhonjiwe noma ongakhonjwa Odatha Yakhe ecutshungulwayo;

"Umyalo" usho imiyalo enikezwa Ngumlawuli Wedatha Kumcubunguli Wedatha ukuze Acubungule Idatha Yomuntu Siqu ngokokuhlinzekwa kwamasevisi ahambisana ne-EULA;

"Idatha Yomuntu Siqu" isho noma yiluphi ulwazi oluphathelene nomuntu okhonjwayo noma ongakhonjwa; umuntu okhombekayo yilowo ongakhonjwa, ngokuqondile noma ngokungaqondile, ikakhulukazi ngokubhekisele kusihlonzi esinjengegama, inombolo yokukhomba, idatha yendawo, isihlonzi esiku-inthanethi, noma into eyodwa noma ngaphezulu eqondene nomzimba wakhe, ukwakheka komzimba, okofuzo, kwengqondo, kwezomnotho, kwamasiko noma kwezenhlahlo;

"Ukwephulwa Kwedatha Yomuntu Siqu" kusho ukwephulwa kwezokuphepha okuholela encithakalweni ngengozi noma ngokungekho emthethweni, ukulahleka, ukuguqlwa, ukudalulwa okungagunyaziwe, noma ukufinyelela, ukudluliswa Kwedatha Yomuntu Siqu, egciniwe noma Ecutshungulwayo ngadlela thize;

"Cubungula"/"Ukucubungula" kusho noma yisiphi isenzo esenziwe Kwidatha Yomuntu Siqu njengokuqoqwa, ukurekhodwa, ukugcinwa, ukulungiswa noma ukuguqlwa, ukubuyisa, ukubonisana, ukusetshenziswa, ukudalulwa ngokudlulisa, ukusabalalisa, ukudlulisa noma ukwenza okunye kutholakale, ukuqondanisa noma inhlanganisela, ukuvinjelwa, ukususwa noma ukucothulwa;

"Amasevisi Okucubungula" asho Ukucutshungulwa Kwedatha Yomuntu Siqu mayelana ne-EULA;

"Izigaba Ezikhethekile Zedatha Yomuntu Siqu" zisho noma iyiphi Idatha Yomuntu Siqu eveza ubuhlanga noma ubuzwe, imibono yezopolitiki, izinkolelo zenkolo noma zefilosofi, noma ubulungu bezinyunyana, izinhlangano noma izisekelo, ukubukeka, izinkolelo zobugebengu nezinyathelo zokuphepha, imininingwane yezezimali nempahla, imininingwane yalapho ikhona, noma imininingwane yezikweletu kanye Nokucutshungulwa kwedatha yezofuzo, idatha ye-biometric ngenhloso yokuhlonza ngokuhlukile umuntu wemvelo, idatha

ephathelene nezempilo noma idatha ephathelene nempilo yomuntu wobulili obungokwemvelo noma ukuthambekela kobulili obuthile noma imininingwane ephathelene nezingane ezineminyaka engu-14 noma ngaphansi;

"Izigaba Ezivamile Zenkontileka"

\zisho izigaba eziwayelekile zenkontileka ezamukelwe Isinqumo Sekhomishini ye-EU 2010/87 sangomhla ka-5 Febhuwari 2010 ezigabeni ezivamile zenkontileka zokudlulisa kwedatha yomuntu siqu kubacubunguli abasungulwe emazweni wesithathu noma enye nenye isethi yezigaba ezivamile okuvunyelenwe ngazo phakathi Kwamalungu. Lapho Umlawuli Wedatha esungulwe endaweni engaphandle kwe-European Union, izinkomba zamazwe angamalungu kuzinhlinzeko eziqinile Zezigaba Ezivamile Zenkontileka zizothathwa njengezinkomba zamandla okulawula lapho Umlawuli Wedatha asungulwe khona;

"Umcubunguli Ongaphansi"

usho noma yikuphi ukucubungula okubandakanyeka Kumlawuli Wedatha (noma nganoma iyimuphi omunye Umcubunguli Ongaphansi Wedatha) ukuze acubungule Idatha Yomuntu Siqu esikhundleni Somlawuli Wedatha ngokwemiyalo yayo kanye nemibandela yenkontileka engaphansi ebhaliwe.

- 1.2 Amagama-ncazo nezihloko zesigaba ezesetshenziswe ngenhoso yesikhombo nokusebenziseka kalula kuphela, akuyona ingxenyenye yale DPA, futhi ngeke isetshenziselwe ukwakha le DPA.

2. UBUBANZI NESICELO SALE DPA

- 2.1 Le DPA yengeza kuphela izinhlinzeko ze-EULA ngokuqondene Namasevisi Wokucubungula anikezwe Ngumcubunguli Wedatha Kumlawuli Wedatha ngokulandela i-EULA.

3. UKUCUTSHUNGULWA KWEDATHA

- 3.1 Umcubunguli Wedatha uyavuma ukucubungula Idatha Yomuntu Siqu ngokwemigomo nemibandela ebekwe kule DPA, futhi ikakhulukazi Umcubunguli Wedatha wenza:

3.1.1 ukucubungula Idatha Yomuntu Siqu kuphela egameni Lomlawuli Wedatha futhi ngaso sonke isikhathi ngokuhambisana \Nemiyalo Yesilawuli Sedatha njengoba kuchaziwe kule DPA, nayo yonke imithetho esebebenzayo yokuvikela imininingwane;

3.1.2 isiqiniseko sokuthi noma yibaphi abasebenzi abaphathiswe Amasevisi Okucubungula bazibophezele ekugcinweni okuyimfihlo noma babe ngaphansi kwesibopho esifanele semithetho yemfihlo;

3.1.3 ukuthatha izinyathelo zobuchwepheshe, zomzimba nezenhlangano ukuqinisekisa ukuphepha nokugcinwa kwemfihlo Yedatha Yomuntu Siqu kanye nokuvikelwa okufanele Kwedatha Yomuntu Siqu esetshenzisiwe egameni Lomlawuli Wedatha ekusetshenzisweni kabi nasekulahlekeni, njengoba kuhlinzekiwe Kusheduli 2 yale DPA;

3.1.4 ukuthi Umlawuli Wedatha uzokwazisa ngokushesha mayelana: (a) nanoma yisiphi isicelo esibophezelwa ngokomthetho sokudalulwa Kwedatha Yomuntu Siqu yisiphathimandla sikahulumeni ngaphandle kwalapho kunqatshelwe ngenye indlela, njengokuvinjelwa ngaphansi komthetho wobugebengu ukugcina imfihlo yokuphoqelelw komthetho noma ukuphenywa kwezobunhloli, (b) noma yikuphi Ukwephulwa Kwedatha Yomuntu Siqukuphulwa okuthinta Idatha Yomuntu Siqu ecutshungulwa esikhundleni Somlawuli Wedatha, (c) noma yisiphi isicelo esitholwe ngokuqondile Kubanikazi Bedatha (kuhlanganise namalungelo okufinyelela, ukulungiswa, ukususwa, ukuphikiswa, ukuvinjelwa, ukudlulisa kwedatha, kanye nelungelo lokungabi ngaphansi kwesinqumo esincike kuphela Ekucubungulen okuzenzakalelayo, okuhlanganisa nokuphrinta); Umcubunguli Wedatha (i) ngeke aphendule ngokuqondile kuleso sicelo, ngaphandle kokwazisa Umnikazi Wedatha ukuthi usebenza egameni Lomlawuli Wedatha futhi anikeze Umnikazi Wedatha imininingwane yokuxhumana Nomlawuli Wedatha, futhi (ii) acabangele uhlolo Lokucubungula, kuzosiza Umlawuli Wedatha ngezinyathelo ezifanele zobuchwepheshe, ngokomzimba \nangezinyathelo zenhlangano, ngokwazi ukuthi lokhu kungenzeka, ukuze kufezeke umbono wesibopho Somlawuli Wedatha \ekuphenduleni izicelo zokusebenzisa amalungelo Omnikazi Wedatha;

- 3.1.5 ukuhlinzeka ngokubambisana okuhle kwezentengiselwano Kumlawuli Wedatha ukusiza Umlawuli Wedatha ukuthi athobele izibopho zakhe zomthetho ezihlobene nokuphepha Kwedatha Yomuntu Siqu, njengokuthi: ukwaziswa Kokwephulwa Kwedatha Yomuntu Siqu kuziphathimandla ezifanele eziphethe, ukuxhumana Ngokwephulwa Kwedatha Yomuntu Siqu Kumnikazi Wedatha othintekile futhi, lapho kufanele, ukuqaliswa kokuhlolwa komthelela wokuvikelwa kwedatha nokubonisana kwangaphambili neziphathimandla eziphethe, kucatshangelwa uhlolo Lokucubungula nolwazi olutholakala Kumcubunguli Wedatha;
- 3.1.6 ukwenza ukuthi Umlawuli Wedatha athole yonke imininingwane edingekayo ukufakazel ukuhambisana nezibopho ezipbekwe kule DPA futhi avumele futhi abambe iqhaza eku-odithweni, kuhlanganise nokuhlolwa, okwensiwa Ngumlawuli Wedatha noma omunye u-oditha onikwe amandla Ngumlawuli Wedatha njengoba kushiwo Esigaben 6; kanye,
- 3.1.7 nokuthi noma yimaphi Amasevisi Okucubungula enziwa Umcubunguli Ongaphansi azokwensiwa ngokuya Kwasigaba 7.
- 3.2 Mayelana Namasevisi Okucubungula, Umlawuli Wedatha uzoba nesibopho sokuhambisana nazo zonke izimfuneko ezisebenza kuye ngaphansi komthetho osebenzayo ngokuqondene Nokucutshungulwa Kwedatha Yomuntu Siqu kanye Nemiyalo eyinikeza Umcubunguli Wedatha. Ikakhulukazi kodwa ngaphandle kokubandlulula kokujwayelekile kwalokhu okungenha, Umlawuli Wedatha uyamukela futhi iyavuma ukuthi uzobophezeleka kokulandelayo: (i) ukunemba, ikhwalithi nokuba semthethweni Kwedatha Yomuntu Siqu; (ii) ukuhambisana nakho konke okudingeka obala kanye nezimfuneko zomthetho ngaphansi komthetho osebenzayo ekuqoqweni nasekusetshenzisweni Kwedatha yomuntu siqu, kuhlanganise nokuthola noma yikuphi ukuvuma okudingekile kanye nokugunyazwa okuvela Kubanikazi Bedatha noma ngenye indlela; (iii) ukuqinisekisa ukuthi Umlawuli Wedatha unelungelo lokudlulisa, noma ukuniikeza ukufinyelela, Kwidatha Yomuntu Siqu Kumcubunguli Wedatha nokuthi Umlawuli Wedatha anikeze izaziso ezidingekayo futhi athole noma yiziphi izimvume ezidingekayo kanye/noma ukugunyazwa ngokuqondene nalokho kudluliswa noma ukufinyelela futhi, ngokuvame kakhulu, Ekucutshungulweni ngokuya ngemigomo ye-EULA (kuhlanganise nale DPA); kanye (iv) nokuqinisekisa ukuthi Imiyalo yayo iyahambisana nemithetho esebenzayo. Lapho isicelo sivela Kumcubunguli Wedatha, Umlawuli Wedatha uzonikeza Umcubunguli Wedatha kungakapheli izinsuku ezintathu (3) zebhizinisi ubufakazi obubhaliwe bezaziso ezinjalo, imvume kanye nokugunyazwa. Umlawuli Wedatha negeke afake Kumasevisi Okucubungula, noma ngandlela thize anikeze Umcubunguli Wedatha, nganoma yiziphi izigaba ezikhethekile Zedatha Yomuntu Siqu, ngaphandle kwalapho uma kuvunyelwane ngokuhlkile ngokubhalwe Ngumlawuli Wedatha. Umlawuli Wedatha uzokwazisa Umcubunguli Wedatha, ngokushesha futhi ngaphandle kokubambezeleka okungenasidingo, uma Umlawuli Wedatha engawkazi ukuhambisana nezibopho zakhe ezipbekwe kule DPA. Umsebenzisi Ogunyaziwe unesibopho sokubuyekeza Amasevisi Okucubungula, kuhlanganise nanoma yimaphi amadokhumenti nezici zokuphepha ezitholakalayo, ukunquma ukuthi ziyazanelisa yini izimfuneko \Zomsebenzisi Ogunyaziwe , izidingo zebhizinisi, kanye nezibopho zomthetho.

- 3.3 Umlawuli Wedatha ugunyaza Umcubunguli Wedatha ukuba enze ukuthi Idatha Yomuntu Siqu Ecubunguliwe isebenze ngegama le-EULA ukuze kutholakale imininingwane yezibalo ephathelene nokusetshenziswa Kohlelo Olunelaisense kanye nemikhiqizo nemishini ye-Lincoln. Ukusetshenziswa okuqhubekayo kwemininingwane yezibalo okuvela Kumcubunguli Wedatha akukho ngaphansi kokugunyazwa kwangaphambili okuvela Kumlawuli Wedatha.

4. UKUDLULISELWA KWEDATHA YAMAZWE NGAMAZWE

- 4.1 Umlawuli Wedatha ngalokhu uyamukela futhi uyavuma ukuthi, ngokuhlinzeka ngezinsizakalo Zokucubungula ngaphansi kwe-EULA, Umcubunguli Wedatha angadlulisa futhi agcine Idatha Yomuntu Siqu e-United States of America, nakwelinye izwe lapho Umcubunguli Wedatha akhona, ngenhoso yokuhlinzeka Ngamasevisi Okucubungula. Ngakho-ke, ngesikhathi sokuhlinzekwa Kwamasevisi Okucubungula, kungahle kudingke ukuthi kudluliselwe Idatha Yomuntu Siqu Kumcubunguli Wedatha otholakala ngaphandle kwezwe lokusungulwa Komlawuli Wedatha. Uma Umlawuli Wedatha etholakala e-European Economic Area noma e-Switzerland, Amalungu azibophezela ukusebenzia imibandela Yezigaba Ezivamile Zenkontileka yokudluliswa Kwedatha Yomuntu Siqu Ngumlawuli Wedatha (esebenza njengomthumeli wedatha Ngokwezigaba Ezivamile Zenkontileka) Umcubunguli Wedatha (osebenza njengomngenisi wedatha ngokulandela Izigaba Ezivamile Zenkontileka).

- 4.2 Uma Umlawuli Wedatha etholakala ngaphandle kwe-European Economic Area kanye naseSwitzerland, Amalungu asazozibophezela ukusebeniza imibandela Yezigaba Ezivamile Zenkontileka yokudluliswa Kwedatha Yomuntu Siqu Ngumlawuli Wedatha (esebenza njengomthumeli wedatha Ngokwezigaba Ezivamile Zenkontileka) Umcubunguli Wedatha (osebenza njengomngenisi wedatha ngokulandela Izigaba Ezivamile Zenkontileka), uma nje Izigaba Ezivamile Zenkontileka zidingeka ngokomthetho futhi zanele ukuhlangabezana nezimfuneko zemithethonqubo yokuvikelwa kwedatha esebezayo yokudluliswa Kwedatha Yomuntu Siqu Ngumlawuli Wedatha Kumcubunguli Wedatha ngokwe-EULA.
- 4.3 Uma Amaqembu esebenzisa Izigaba Ezivamile Zenkontileka ngokwezigaba 4.1 noma 4.2 zale DPA:
- 4.3.1 Isithasiselo 1 Sezigaba Ezivamile Zenkontileka sizo setshenzisa ngale ndlela elandelayo: (a) Umthumeli wedatha: Umlawuli Wedatha, (b) Umgenini wedatha: Umcubunguli Wedatha, (c) Abanikazi bedatha: abasebenzi Bokulawula Idatha (Umsebenzisi Ogunyaziwe), (d) Izigaba zedatha: idatha ephathelene nokusetshenzisa kwemikhiqizo nemishini ephethwe, enelaisensi, noma ephethwe Ngumcubunguli Wedatha, njengoba ihlolwe Yisicelo Esinelaisense ngokwe-EULA, kuhlanganise nedatha yokubhalisa (okungukuthi, amagama abasebenzisi namaphasiwed), (e) Izigaba Ezikhethekile Zedatha Yomuntu Siqu: N/A, kanye (f) Nemisebenzi yokucubungula: ukuqoqwa, ukukopishwa, ukudluliswa, ukugcinwa, ukuguqulwa, ukususwa kanye neminye imisebenzi edingekayo Yamasevisi Wokucubungula alandelwayo ngokwe-EULA.
 - 4.3.2 Incazeloyezinyathelo zokuphepha kwezobuchwepheshe, zomzimba nezenhlangano ezisetshenziswe Ngumcubunguli Wedatha osebenza njengomngenisi wedatha ngenhoso Yesithasiselo 2 Sezigaba Ezivamile Zenkontileka kuzoba njengoba kunikezwe Kushejuli 2 yale DPA.
- 4.4 \\\Uma Izigaba Ezivamile Zenkontileka zisebenza phakathi Kwamalungu ngokulandela Isigaba 4.1 noma 4.2, izinhlinze ko zavo zizothathwa njengezihlanganisiwe ngokubhekisele kule DPA, ngaphandle kwalapho uma Izigaba Ezivamile Zenkontileka zisebenza njengombhalo ozimele ngokulandela Isigaba 4.5.
- 4.5 \\\Ngokwezinga elidingekayo kwimithethonqubo yokuvikelwa kwedatha esebezayo, Amaqembu azongena futhi asebenzise Izigaba Ezivamile Zenkontileka njengedokumenti ehlukile.
- 5. UKUNQANYULWA**
- 5.1 Le DPA izosebenza kusukela mhla kuqala ukusebenza i-EULA.
- 5.2 Le DPA izonqamuka ngokuzenzakalelayo ngesikhathi sokunqanyulwa noma sokuphelelwa yisikhathi (a) kwe-EULA noma (b) Kwezibopho \Zomcubunguli Wedatha ngokuqondene Namasevisi Okucubungula, futhi ukunqanyulwa okunjalo ngeke kudinge igunya lenkantolo noma ukuqhutshwa kwenkantolo noma esinye isenzo Somcubunguli Wedatha, Umlawuli Wedatha noma elinye iqembu ukuze isebenze. Lapho kusebenza khona, ekunqanyulweni kwale DPA, Umcubunguli Wedatha uzobuyela Kumlawuli \Wedatha noma asuse, ngesicelo Somlawuli Wedatha, yonke Idatha Yomuntu Siqu Yomlawuli Wedatha egcinwe kuye noma engaphansi kwakhe. Ngokwesicelo Somlawuli Wedatha, Umcubunguli Wedatha uzoqinisekisa ukuhambisana nalezi zibopho ngokubhala futhi asuse wonke amakhophi akhona, ngaphandle kwalapho uma umthetho osebenzayo udinga kugcinwe noma uvumela ukugcinwa Kwedatha Yomuntu Siqu.
- 5.3 Umlawuli Wedatha uzoba nelungelo lokunqamula le-DPA ngesaziso ngokubhalela Umcubunguli Wedatha uma Umcubunguli Wedatha ayephule ngokweqile noma ngokuqhube kayo le DPA, okuthi uma kwenzeka kwephulwa amandla okulungisa, okungeke kulungiswe phakathi nezinsuku ezingamashumi amathathu (30) zokusebenza kusukela ngosuku Umcubunguli Wedatha athole ngalo isaziso esivela Kumlawuli Wedatha esikhomba ukwephulwa futhi esidinga ikhambi laso.
- 5.4 Umcubunguli Wedatha uzoba nelungelo lokunqamula le-DPA ngesaziso ngokubhalela Umlawuli Wedatha uma Umcubunguli Wedatha ayephule ngokweqile noma ngokuqhube kayo le DPA, okuthi uma kwenzeka kwephulwa amandla okulungisa, okungeke kulungiswe phakathi nezinsuku ezingamashumi amathathu (30) zokusebenza kusukela ngosuku Umlawuli Wedatha athole ngalo isaziso esivela Kumcubunguli Wedatha esikhomba ukwephulwa futhi esidinga ikhambi laso.

6. AMA-ODITHI NEZICELO ZOLWAZI

- 6.1. Ngaphakathi komkhawulo woku-odithwa okukodwa (1) ngonyaka futhi ngokwesaziso Somlawuli Wedatha ngesaziso sangaphambi kwezinsuku ezingamashumi amathathu (30), ngaphandle kwalapho uma uku-odithwa kucelwe isiphathimandla esingamele, Umlawuli Wedatha \phakathi nesikhathi esivamile sebhizinisi \ amahora, ngaphandle kokuphazamisa ngokungafanele ukusebenza kwebhizinisi Lomcubunguli Wedatha , ngokomuntu siqu uku-oditha Umcubunguli Wedatha, noma uqoke u-oditha wesithathu obhekene nezibopho zobumfihlo zokwenza lokho ku-oditha.
- 6.2. Umcubunguli Wedatha uzobambisana uma ku-odithwa ngaphansi kwalesi Sigaba 6 futhi anikeze Umlawuli Wedatha yonke imininingwane edingekayo yokwenza lokho ku-oditha. Umlawuli Wedatha uzokhokha imali nezindleko ezitholwe yiqembu ngokuqondene noku-oditha ngaphansi kwalesi Sigaba 6.

7. UKUQOKWA KWABACUBUNGULI ABANGAPHANSI

- 7.1 Umlawuli Wedatha ugunyaza Umcubunguli Wedatha ukuthi asebenzise amasevisi Wabacubunguli Abangaphansi abhalwe ekhasini elifinyeleleka ku-\[<https://www.lincolnelectric.com/en/Legal-Information/Subprocessors>\], ngokuqondene nje nokusebenza Kwamasevisi axhumene ne-EULA.
- 7.2 Umlawuli Wedatha ugunyaza Umcubunguli Wedatha ukuthi isebeenzise amasevisi Omcubunguli Ongaphansi omusha, ngokwesaziso sangaphambilini Kumlawuli Wedatha Ngomcubunguli Wedatha enesaziso sezinsuku eziyishumi nanhlanu (15) ngaphambi koshintsho Lomcubunguli Ongaphansi. Uma Umlawuli Wedatha ephikisa ushintsho Lomcubunguli Ongaphansi owazisiwe, Umlawuli Wedatha, phakathi naso sonke isikhathi sesaziso, angayinqamula le DPA ngokubhala. Uma Umlawuli Wedatha enganqamuli kungakapheli isikhathi sesaziso, lokhu kubeka ngokomthetho ngemvume Yomlawuli Wedatha oshintshweni elazisiwe Lomcubunguli Ongaphansi.
- 7.3 Kunoma ikuphi, lapho Umcubunguli Wedatha esebeenzisa amasevisi Womcubunguli Ongaphansi wokugcina, ngenkontileka, ubophezelekile ukuhambisana nezibopho ezifanayo lapho Umcubunguli Wedatha eboshwe khona ngokwemigomo Yokucutshungulwa Kwedatha Yomuntu Siqu ngaphansi kwale DPA.

8. IZINHLINZEKO EZIHLUKAHLUKENE

- 8.1 Ukuchitshiyela noma ukwengezwa kule DPA kumele kwenziwe ngokubhala ukuze kusebenze. Ngaphandle kwalokhu okungenhla, Umcubunguli Wedatha, nganoma yisiphi isikhathi futhi ngaphandle kwesaziso Kumlawuli Wedatha, angachibiyela izinyathelo zobuchwepheshe, ezingokoqobo nezenhlangano ezbekwe Kushejuli 2, uma nje ukuchitshiyela okunjalo kungazithinti kakhulu ezokuphepha, imfihlo noma ubuqotho Bedatha Yomuntu Siqu.
- 8.2. \Izinkomba ezikule DPA “ngombhalo” noma “ezibhaliwe” zihlanganisa i-imayili yezokuxhumana kanye ne-imayili eqinisekisiwe.
- 8.3. Uma kwenzeka noma yikuphi ukuhlinzekwa kwale DPA kungasebenzi, lokhu ngeke kuthinte ubuqiniso bemigomo ese. Uma kwenzeka ukungasebenzi kwanoma yikuphi ukuhlinzekwa kwale DPA, Amalungu, nganoma iyiphi indlela, ezama, ngobuqotho, emiselela ukuhlinzekwa okungavumelekile ngokunye, okuphoqeleyalo, okugunyaziwe nokusemthethweni, okuba namandla amakhulu ngokomthetho kulingana noma kulinganisene naleyo yokunikezwa kokuqala.
- 8.4. Le DPA ilawulwa wumthetho owengamele ofanayo newe-EULA.

ISHEJULI 1 - IZIPHATHIMANDLA ZEMIGOMO EQONDILE

Lapho Umlawuli Wedatha ezinze kwesinye seziphathimandla esisohlwini lwale Sheduli 1 imigomo elandelayo iyasetshenzisa ku-DPA, futhi leyo migomo iyothatha isikhundla futhi ilawule uma kwenzeka kuba nokungqubuzana nezinye izinhlinzko ze-DPA. Yonke imigomo eku-EULA engashintshwanga yimigomo yeziphathimandla ezisebenzayo-ngokuqondile kule Sheduli ihlala ingashintshiwe futhi iseberza ngokugcwele.
