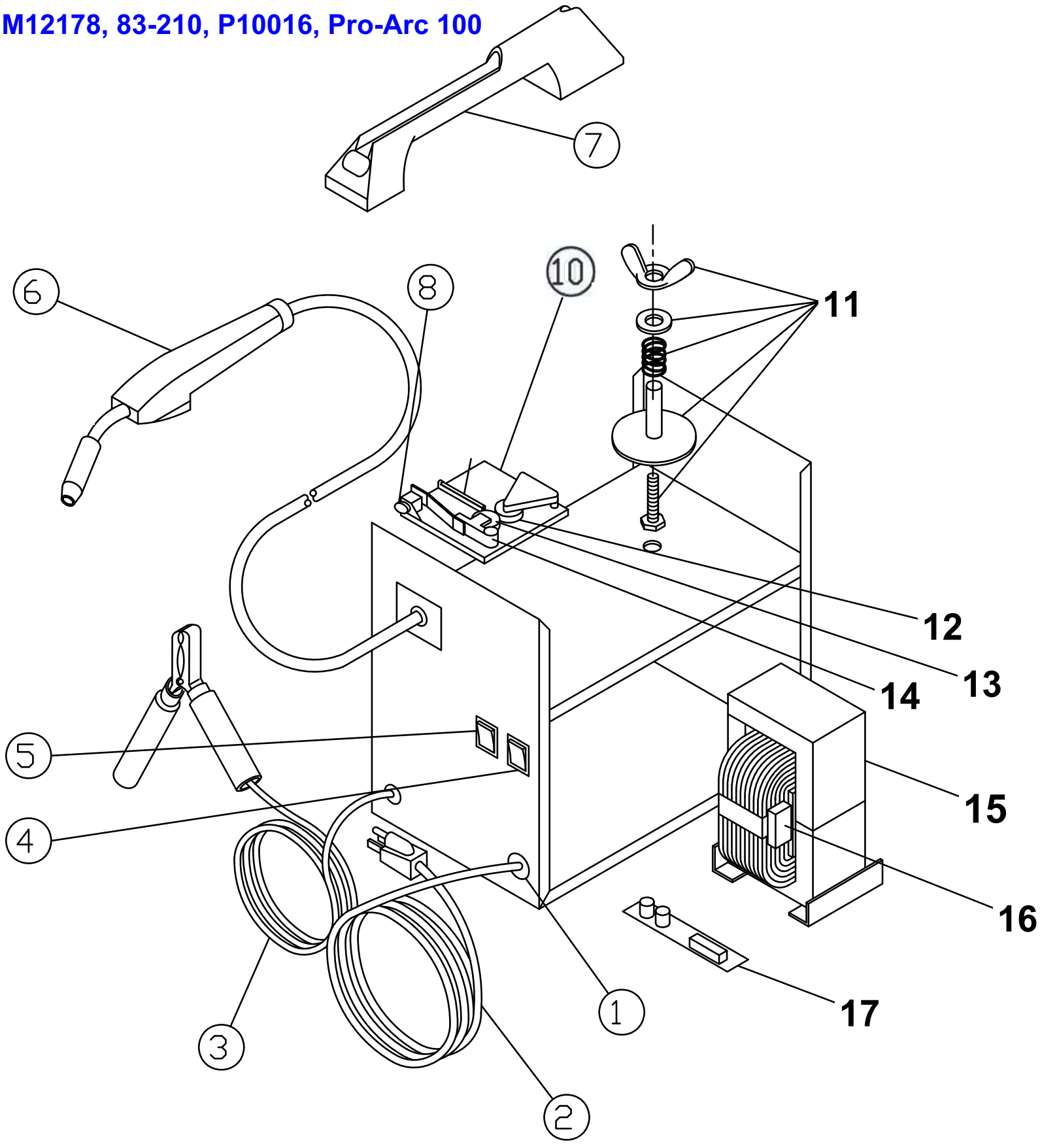

LINCOLN, a division of McNeil (Ohio) Corp., a subsidiary of Pentair, Inc., warrants that all MIG Welding Equipment, Gas Welding Equipment, Plasma Cutting Equipment, Models M15525, M15537, M25027, M25028, M25110, M25120, M25250 and M25260 manufactured by it under the Marquette trade name will be free from defects in material and workmanship during the one (1) year following the date of purchase, except the Mig Welder and Plasma Cutter torch assemblies will be free from defects in material and workmanship during the ninety (90) days following the date of purchase. This warranty is extended to the original retailer purchaser only. If the equipment under this warranty proves to be defective during this warranty period, it will be replaced or repaired, at Lincoln's sole option, without charge. To obtain repair or replacement, it must be shipped, transportation charges prepaid, with proof of date of purchase to a Lincoln distributor of Marquette products, within the one (1) year following the date of purchase, except within the ninety (90) days following the date of purchase for the MIG Welder or Plasma Cutter torch assemblies. This warranty does not apply to parts damaged from accident, overload, or abuse, nor does it apply to any equipment which has been altered or used with special attachments other than those recommended by Lincoln. No other express warranty applies to welding equipment manufactured by Lincoln under the Marquette trade name.

ANY IMPLIED WARRANTIES applicable to welding equipment models manufactured by Lincoln under the Marquette trade name, **INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WILL LAST ONLY FOR ONE (1) YEAR FROM THE DATE OF PURCHASE, EXCEPT FOR ANY IMPLIED WARRANTIES APPLICABLE TO THE MIG WELDER OR PLASMA CUTTER TORCH ASSEMBLIES WHICH WILL LAST FOR NINETY (90) DAYS FROM THE DATE OF PURCHASE. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.**

In no event shall Lincoln be liable for incidental or consequential damages.
