CARBON ARC SAFET	WARNING
HAZARD	SAFETY PRACTICES
Electric shock can kill	<ul> <li>Wear dry gloves free of holes or split seams. Change as necessary to keep gloves dry.</li> <li>Do not touch electrically "hot" parts or the cutting/gouging torch with bare skin or wet clothing.</li> <li>Keep the cutting/gouging torch and cable insulation in good condition. Do not use if insulation is damaged/missing.</li> </ul>
Fumes and gases can be dangerous  See	<ul> <li>Read the warnings and instructions on the product label and Safety Data Sheet (SDS) available in the workplace (ask your supervisor). Provide additional ventilation and exhaust where special ventilation is needed or if using this product in a confined area.</li> </ul>
Health Hazards	<ul> <li>Know what the base metal is, and determine if there is any paint, plating, or coating that could expose you to toxic fumes and/or gases. Remove it from the metal surface, if possible.</li> </ul>
Page 2	Position your head away from the fume plume to keep the amount of fume you breathe as low as possible.
Use adequate ventilation and/or exhaust	<ul> <li>Use adequate ventilation and/or exhaust to keep the air you breathe clear and comfortable. Your work area should have enough ventilation and/or local exhaust to control your exposure to the fumes and gases so the applicable exposure limits are not exceeded. If you have any concern about ventilation or your exposure level, ask your employer to confirm that exposures do not exceed those limits by obtaining and analyzing a representative sample of air in the breathing zone.</li> </ul>
	• If you start to feel uncomfortable, dizzy or nauseous, you may be overexposed to fumes and gases, or suffering from oxygen deficiency. Stop using the product and get some fresh air immediately. Notify your supervisor and co-workers so the situation can be corrected and other workers can avoid the hazard. Be sure you are following these safe practices, the product labeling and SDS and improve the ventilation in your area. Do not resume operations until the situation has been corrected.
	Use a respirator if exposure to fume cannot be controlled or if outside and natural air movement is not enough to keep fume out of your breathing zone.
Molten metal and sparks can cause fire or explosion	<ul> <li>Do not use this product on containers which have held combustible materials unless procedures for the safe welding and cutting of containers are carefully followed (see AWS F4.1).</li> <li>Remove flammable materials from work area or shield from hot metal &amp; heat.</li> <li>Keep a fire watch in area during and after using this product.</li> </ul>
	<ul> <li>Keep a fire extinguisher in the work area.</li> <li>Wear flame resistant clothing and headgear that is free of frayed edges.</li> <li>Handle all compressed gas cylinders in accordance with sound safety practice: store cylinders upright and secure them using an approved lock-down device. Always use the correct pressure regulator for the specific gas. Separate fuel gas and oxidizers when not in use.</li> </ul>
Arc rays, sparks & molten metal can burn eyes and skin	<ul> <li>Select a proper filter lens which provides adequate protection for your eyes and is comfortable for you while using this product.</li> <li>Always use a helmet and/or appropriate head, face and eye protection during application.</li> <li>Process may generate UV radiation. Wear flame resistant clothing which provides full coverage for your skin.</li> </ul>

Use earplugs to keep noise, sparks and molten metal from damaging your ears.

#### **NOISE**

The carbon arc cutting or gouging process generates high levels of noise, potentially exposing workers to hazardous sound levels from 108-120 dB(A). Workers who perform the cutting or gouging process, as well as those workers in close proximity to the process, are at risk for noise-induced hearing loss. Ensure affected workers wear adequate hearing protection when carbon arc cutting or gouging is taking place in order to prevent overexposures to noise.

#### **FUME**

The carbon arc cutting or gouging process involves using a carbon electrode in combination with compressed air to melt and remove metal from a metallic or metal alloy material surface. This process also produces airborne metallic fumes which may contain copper and metallic oxides directly related to the composition of the metal or metal alloy surface to which the process is being applied. Carbon arc cutting or gouging of alloy materials containing chromium may produce airborne hexavalent chromium, a known respiratory carcinogen. Any surface coatings or lubricants will also contribute airborne contaminants when carbon arc cutting or gouging is applied. Refer to the SDS for any surface coating materials as well as the SDS for the metal material being worked. Take all precautions necessary to prevent overexposures to airborne contaminants.

#### **HEALTH HAZARDS**

The most immediate effects of exposure to carbon arc cutting or gouging fumes and gases depend on the amount and length of exposure. They are temporary, and include symptoms of burning eyes and skin, dizziness, nausea, and fever. The International Agency for Research on Cancer (IARC) has determined that welding fumes and ultraviolet radiation from welding are carcinogenic to humans. According to IARC, welding fumes cause cancer of the lung and positive associations have been observed with cancer of the kidney. Also according to IARC, ultraviolet radiation from welding causes ocular melanoma. IARC identifies gouging, brazing, carbon arc or plasma arc cutting, and soldering as processes closely related to welding. Long-term exposures can also lead to siderosis (iron deposits in the lungs) and may affect breathing. Bronchitis and some lung fibrosis have been reported.

Carbon arc cutting or gouging fumes may contain compounds which are reported to have the following health effects of overexposure. Listed below are materials with significant potential health effects that are commonly found in the fume. This list is not specific to any particular welding, cutting, gouging or allied products/processes.

- Chromium and its compounds are on the IARC and NTP lists as posing a cancer risk to humans. Some forms of chromium are known or suspected to cause lung cancer, and asthma has been reported.
- . Cobalt may cause respiratory irritation, lung damage, asthma, and chronic bronchitis. Skin contact may cause dermatitis.
- Manganese overexposure may affect the brain and central nervous system, resulting in poor coordination, difficulty speaking, and arm or leg tremor. This condition can be irreversible.
- Nickel and its compounds are on the IARC and NTP lists as posing respiratory cancer risk, and are skin sensitizers with symptoms ranging from slight itch to severe dermatitis.
- Vanadium Pentoxide is a respiratory irritant and acute overexposures have resulted in shortness of breath and pulmonary edema. The IARC listing for vanadium pentoxide is 2B, possibly carcinogenic to humans.

Materials used in base metal coatings may include cadmium, lead, zinc and various organic materials which have health effects. Refer to the SDS for the coating being used.

#### **DISPOSAL INFORMATION**
