This Student Privacy Notice and Policy (hereinafter, "**Student Notice**") describes the policy on, and procedures related to, the collection, use, and disclosure of Personal Information that is provided to the Lincoln Electric Welding School directly or during any other professional training or educational class operated or funded by the Lincoln Electric Company or its divisions, affiliates, and subsidiaries. In addition, this Student Notice addresses the collection, use, and disclosure of Student Records (including the Personal Information contained therein) by the Lincoln Electric Welding School and the rights and responsibilities you may have with respect to such Student Records and Personal Information.

THE LINCOLN ELECTRIC WELDING SCHOOL AND ITS ONLINE SERVICES ARE NOT DIRECTED TO ANYONE UNDER THE AGE OF FIFTEEN (15). IF YOU ARE UNDER THE AGE OF FIFTEEN (15) PLEASE DO NOT USE OUR SERVICES WITHOUT THE DIRECT AND EXPRESS CONSENT OF YOUR PARENT OR LEGAL GUARDIAN.

#### 1. **Definitions**

For purposes of this Student Notice, the following definitions shall apply:

The term "<u>Controller</u>" refers to the natural or legal person, public authority, agency, or other body which, alone or jointly with others, determines the purposes and means of the processing of Personal Information.

The term "<u>Data Protection Law</u>" refers to any data protection law, statute, and regulation applicable to the Lincoln Electric Welding School in the context of its collection, processing, retention, dissemination, disclosure, transfer, disposal, or use of Personal Information.

The term "Personal Information" refers to any information, or a combination of pieces of information, that can directly or indirectly identify an individual, household, or device, and that is subject to, or otherwise afforded protection under, an applicable Data Protection Law. Personal Information includes (but is not limited to) such personally identifiable information set forth in a Student Record.

The term "<u>Student Record</u>" refers to all academic records, applications, documents, and similar materials, in whatever format and medium, related to an individual's registration to, participation in, or other contact with, the Lincoln Electric Welding School.

## 2. Scope

This Student Notice applies to (i) current and former students of the Lincoln Electric Welding School, (ii) individuals who have registered or otherwise provided information to the Lincoln Electric Welding School, regardless of whether they have attended any education, learning, or training events, and (iii) individuals who otherwise provide information, either directly or indirectly, to the Lincoln Electric Welding School as part of their, or their employer's, participation in a program administered, facilitated, or funded by the Lincoln Electric Welding School (program participants and sponsors). In addition, this Student Notice applies to all information and data provided to any website or online service operated by, or under the control of, the Lincoln Electric



Welding School or a third party acting on our behalf (collectively, the "Welding School Websites"). In the event that an individual accesses any other website or online service operated by the Lincoln Electric Company or any other affiliated company, then the privacy policy applicable to such other website or online service (and not this Student Notice) shall apply to Personal Information collected therefrom or processed thereon.

## 3. Identification of Data Controllers Under Data Protection Law

This section applies only to the extent required under local Data Protection Law, such as that in the EU, UK, or other applicable jurisdictions.

For purposes of this Student Notice, the entity with which you have a primary educational relationship (such as the entity providing, operating, or facilitating the professional training or educational classes, or an entity whose representatives you have interacted with via educational platforms or video teleconferencing) will act as the Controller of your Personal Information. In addition, The Lincoln Electric Company, located at 22801 St. Clair Avenue, Cleveland, Ohio 44117-1199, USA, will serve as a joint Controller of the Personal Information collected, used, disclosed, or otherwise processed by the Lincoln Electric Welding School (including as contained in Student Records). If you have questions about who the Controller of your Personal Information is, please contact the Data Protection and Privacy Coordinator as specified in Section 15 of this Student Notice.

#### 4. Programs Funded or Sponsored by Public Authorities

The Lincoln Electric Welding School may administer programs and curriculum that are sponsored or funded by public authorities. In the event you participate in any such program or scholarship sponsored or funded by public authorities, you hereby acknowledge that your Personal Information will be collected, used, and otherwise processed in accordance with the applicable rules, regulations, and requirements related to this Student Notice and to the program or scholarship sponsored or funded by public authorities.

#### 5. Collection of Personal Information; Data Sources

The Lincoln Electric Welding School collects a broad range of Personal Information about its students, applicants, program participants and sponsors. We may collect this Personal Information directly from the student (e.g., registration forms, school participation) or from a third party (e.g. student's employer, instructors, vocational training schools, background-check service providers, distributors of our services).

Depending on (i) the applicable law of the country in which you reside and/or (ii) the specific program in which you participate, we may collect the following categories and types of Personal Information as part of our routine business and our curriculum and programs. Note that some of the Personal Information set forth below is only collected as part of a specific program we are providing (e.g., a program sponsored or funded by a public authority).

Note that if we process your Personal Information for the purposes of compliance with legal or contractual obligations, or for entering into any contract with you, you have to provide us with certain Personal Information when requested. Otherwise, we may not be able to perform the contract which we have entered into with you, or we may be prevented from complying with our legal obligations, as the case may be. In such event, we may decline to enter into any contract with you or cancel any services related to you, whether in whole or in part.

# 6. Use of Personal Information and Legal Basis for Processing

The Lincoln Electric Welding School uses the following categories of Personal Information (or certain data elements/fields within each of these categories) for a variety of purposes related to the administration, functionality, and marketing of our educational programs and resources, as well as other legitimate business activities, on the basis of the following legal bases in accordance with the applicable Data Protection Laws:

## 7. <u>Disclosure of Personal Information</u>

The Lincoln Electric Welding School retains Personal Information in a confidential manner and does not sell, lease, or rent Personal Information to any other party for profit. We do not share Student Records with a student's parent or legal guardian without the express consent of the student or unless required by applicable law or contract. Notwithstanding the foregoing, the Lincoln Electric Welding School may disclose any of the abovementioned identified Personal Information in the following circumstances:

- To any individual or entity when such disclosure is based upon your written consent on our *Authorization* for *Release of Student Information Form*.
- To administrators and instructors, including teachers and teaching assistants, or other employees at the Lincoln Electric Welding School or the Lincoln Electric Company division, affiliate, or subsidiary to inform them about the completion of our academic program courses.
- To federal, state, or local government agencies or officers, including for legal and regulatory compliance related to the execution of programs sponsored or funded by public authorities.
- To accrediting agencies carrying out their administrative and educational functions.
- To employers or similar professional sponsors of the student applying for, participating in, a program.



- To other employees within the same employer organization, provided such disclosure is consistent with the purpose and structure for how the specific Lincoln Electric Welding School program has been procured by the employer.
- In response to a judicial order, lawfully issued subpoena, or similar regulatory or administrative request.
- To security officers or to law enforcement agencies in the investigation of a specific criminal case.
- To the appropriate person in connection with an emergency, if the knowledge of such information is necessary to protect the health or safety of the student or other persons.
- To federal or state-funded educational agencies and institutions that request records when a student seeks to enroll or is already enrolled.
- To service providers who perform on our behalf (e.g., learning management system providers, payment processors, website administrators, data storage and marketing service providers).
- To third parties in connection with a corporate reorganization, merger or acquisition, or the sale of all, or substantially all, of the Lincoln Electric Welding School or the Lincoln Electric Company's assets.

# 8. Retention Policy and Data Transfers

The Lincoln Electric Welding School maintains Student Records (and the Personal Information therein) only as long as required to comply with the purposes for which the Personal Information was collected, unless otherwise required by law or regulation or to defend or protect our legal or business interests during the applicable statute-of-limitation period.

The Lincoln Electric Welding School is located in the United States, and the data (including Personal Information) that we collect and process is often transferred to the United States. In some circumstances, the Lincoln Electric Welding School uses third-party service providers that retain information and data on our behalf in the United States and in other third countries. Please be aware that information you provide to the Lincoln Electric Welding School may be transferred to the United States or another third country, and that the United States and such other third countries may not provide the same level of data protection as the laws in your country.

When transferring your personal data to a country or territory other than the one you reside in, we will adopt any necessary data transfer safeguards and/or mechanisms in accordance with the applicable Data Protection Law to ensure that your Personal Information is protected.

## 9. Accessing and Transferring Student Records

Students may request access to their Student Records generated at the Lincoln Electric Welding School by completing the *Request for Learner Records Form* and submitting it to the Lincoln Electric Welding School. Students may request that their records be sent to a third party by completing the *Authorization for Release of Student Information Form* and submitting it to the Lincoln Electric Welding School. To protect your confidentiality, we cannot accept requests made over the phone. One form of government-issued photo identification is required in case we have doubts about your identity.

<u>In-Person</u>: In the event you are in the United States, you may submit an "in-person" request for access to Student Records at the Lincoln Electric Welding School's office (22800 Saint Clair Ave., Cleveland, Ohio 44117) between 8:00 a.m. and 4:00 p.m. (EST), Monday through Friday, except for federal holidays.

## 10. Your Rights and Responsibilities

You are permitted, and hereby agree, to only provide Personal Information to the Lincoln Electric Welding School if such Personal Information is accurate, reliable, and relevant to our relationship and only to the extent such disclosure will not violate any applicable data protection law, statute, or regulation or infringe upon any individual's data privacy rights or privileges. If you provide the Lincoln Electric Welding School with any Personal Information about a third party, you expressly represent that you have the full right and authority to provide the Personal Information to the Lincoln Electric Welding School and will fully reimburse the Lincoln Electric Welding School for any expenses incurred, or damages or liabilities arising, from breaches of any of the terms or conditions set forth in this Student Notice.

Depending on the jurisdiction in which you reside, or we operate, you may have certain data protection rights under local Data Protection Laws. We will honor data protection rights only if you have such rights under local Data Protection Law. These rights are subject to the conditions set out in those laws and may include:

- **Right to Information**: You have the right to be informed about the collection and use of your Personal Information. This includes understanding what data is being collected, how it is being used, and why it is necessary for those purposes.
- **Right of Access**: You may request access to your Personal Information, allowing you to receive a copy of the Personal Information we hold about you and verify that we are lawfully processing it.
- **Right to Rectification**: If any Personal Information we hold about you is inaccurate or incomplete, you have the right to have it corrected or completed.
- **Right to Erasure (Right to be Forgotten)**: Under certain circumstances, you can request the deletion or removal of Personal Information where there is no compelling reason for its continued processing.
- **Right to Restrict Processing**: You have rights to 'block' or suppress further use of your data. When processing is restricted, we can still store your data but not use it further.
- **Right to Object**: You have the right to object to the processing of your Personal Information in certain circumstances, including for direct marketing purposes.
- **Right to Data Portability**: This right allows you to receive your Personal Information in a structured, commonly used, and machine-readable format, and to transmit those data to another data Controller.
- **Right to Not Be Subject to Automated Decision-making**. You have the right to not to be subject to a decision based solely on automated processing and to be given more information about why any such decision was made.
- **Right to Refuse or Withdraw Consent**. In case we ask for your consent to process your Personal Information, you are free to refuse to give it. If you have given your consent, you may withdraw it at any time without any adverse consequences. The lawfulness of any processing of your Personal Information that occurred prior to the withdrawal of your consent will not be affected.
- Exercise Your Rights: You can exercise any of the above rights and ask questions about the processing of your Personal Information by contacting us (see Section 15).
- **Right to Make a Complaint**: If you are unhappy with how we are handling your Personal Information, you have the right to make a complaint to your local data protection authority, which will investigate the matter.

Schedule 1 of the Student Notice provides you with further information on the data protection rights that you may be entitled with pursuant to the local Data Protection Laws of the countries where we usually operate.



To exercise any of these data privacy rights outlined above and in Schedule 1, please contact us, or have your authorized agent or representative contact us, in accordance with the instructions below or through the "Contact Us" section listed at the end of this Student Notice. If we have reasonable doubts concerning your identity, we may request you to provide us with a copy of an official ID or passport to verify your identity before responding to your data right request. If you exercise any of these data privacy rights through an authorized agent or representative, please note that we may require further documentation (i.e. authorization or power of attorney) to ensure that they have the authority to act on your behalf.

We will respond to any data requests within the timeframes required by applicable Data Protection Law, and we may charge a fee to facilitate your request where permitted by applicable Data Protection Law. The rights afforded under applicable Data Protection Laws are not always absolute, and the Lincoln Electric Welding School may be permitted under the applicable Data Protection Law to refrain from undertaking any action or changing its data processing activities, in response to a data request you submit to us.

#### 11. Persons with Disabilities

The Lincoln Electric Welding School strives to ensure that every person has access to information related to our products and services, including this Privacy Notice. Please contact us if you would like this Privacy Notice provided in an alternative format, and we will seek to meet your needs.

## 12. Data Security

Keeping Personal Information confidential and secure is of utmost importance to the Lincoln Electric Welding School. We follow standard industry practices to actively protect the confidentiality, security, and integrity of your Personal Information. For example, our employees are bound by internal confidentiality policies and are subject to disciplinary action for any policy violations. We also work to ensure that our third-party service providers are contractually bound to maintain the privacy of any Personal Information shared with them. However, no information system can be fully secure, so we cannot guarantee the absolute security of your Personal Information. Moreover, we are not responsible for the security of information you transmit to the Welding School Websites over networks that we do not control, including the Internet and wireless networks, and you provide us with any information and data at your own risk. To the extent permitted by law, the Lincoln Electric Welding School and the Lincoln Electric Company shall not be liable or otherwise responsible for any data incidents that compromise the confidentiality, integrity, or security of your Personal Information that are caused by a third party. You agree that in the event we are legally required to notify you of a security event regarding the confidentiality, integrity, or availability of your Personal Information, we may provide you such notice via email. The safety and security of your Personal Information also depends on you. Where we have given you (or where you have chosen) a username and password to access our websites or online services, you are responsible for maintaining the security and confidentiality of those credentials, and you must contact us immediately if you have to reason to believe they are compromised.

#### 13. Welding School Websites

The Welding School Websites may also contain third-party advertisements which contain embedded hyperlinks to websites operated by third parties. All third-party advertising is paid for by the relevant third-party advertiser, which you can accept by linking to the third-party advertiser, and is not recommended or endorsed by the Lincoln Electric Welding School. The third-party advertiser is solely responsible for any representations or offers made by it, for the delivery of goods or services, and for its data processing.



# 14. <u>Updates and Amendments</u>

The Lincoln Electric Welding School may update this Student Notice from time to time, and we will, when required by law, notify you of such changes or updates. The updated Student Notice will, to the extent technically feasible, be posted on our website, and your continued provision of Personal Information after we post a revised Student Notice signifies your acceptance of the revised Student Notice.
