

# LINCOLN ELECTRIC FREIGHT CARRIER GUIDE

## DOMESTIC SHIPMENTS INTO CLEVELAND, MENTOR, FORT LORAMIE, COLDWATER, ORRVILLE

If you ship to Lincoln on your own truck with approval from Lincoln, continue to do so. Otherwise ship "Collect" via UPS ground, or the appropriate LTL carrier listed in the attached Routing Guide, or contact Inbound Logistics @ [Kyle.Morris@lincolnelectric.com](mailto:Kyle.Morris@lincolnelectric.com) for assistance.

Before reaching out with any questions please read the below first and if assistance is needed please have clear information before reaching out. Ship from address, ship to address, weight, # of pallets and dimensions, required equipment, pick up date, etc.

**DO NOT ship "Prepaid" and add a freight charge to your invoice unless approved by Lincoln Electric.**

### UPS Ground Shipments:

Ship UPS "Collect". Refer to the UPS account number on our P.O. Use UPS from all states for shipments from 1 lb. to **70 lbs.** total shipment gross weight. Do not ship multiple packages via UPS if the total weight exceeds 70 lbs. gross for all packages combined. High dollar items should be insured when shipping UPS. Call your Lincoln Electric buyer for guidelines. If you do not have your own UPS account, you cannot ship UPS collect. Contact the Inbound Logistics @ [Kyle.Morris@lincolnelectric.com](mailto:Kyle.Morris@lincolnelectric.com) for assistance. **You may not ship hazardous shipments by UPS.** Use the appropriate LTL carrier.

### LTL Shipments Under 10,000 lbs.:

Ship "Collect" using one of the LTL carriers listed on attached LTL Routing Guide for shipments totaling 70 lbs. to 9,999 lbs. gross weight. Locate the state you are shipping from and call the carrier listed at the top of that column to arrange pickup.

### **EXCEPTIONS TO LTL SHIPMENTS:**

Freight takes up one-third, one-half or full truck and weighs less than 10,000 lbs.  
– contact Inbound Logistics Manager for routing.

Freight is in one of the following classes: 400, 300, 250, 150 or 125  
– contact Inbound Logistics Manager for routing.

### Shipments Over 10,000 lbs. OR More Than 50% of a Trailer:

Please contact Inbound Logistics @ [Kyle.Morris@lincolnelectric.com](mailto:Kyle.Morris@lincolnelectric.com) if shipment exceeds 10,000 lbs. or occupies more than 50% of a trailer. Do not use any of the LTL carriers listed in the LTL Routing Guide for shipments over 10,000 lbs. unless instructed by the Lincoln Electric Traffic Department.

### Air Freight:

**If instructed by Lincoln Electric to ship via air freight, use following guidelines:**

Shipments from 1 lb. to **70 lbs.**, ship via UPS Next Day Air - ship "Collect".  
Refer to the UPS account number listed on our PO.

1. Third Party Shipments: **Note: MUST BE APPROVED BY LINCOLN EXCEPTIONS:**

*BUYER* - If your Lincoln Electric buyer has agreed to pay the freight for shipments of material from your supplier to you or from you to another supplier, bill Lincoln Electric as a third party – write on bill of Lading: “Bill To: Lincoln Electric % Data 2 Logistics, PO Box 61050, Ft. Myers, FL 33906”.

2. Special Equipment Needs

If the material shipped to Lincoln requires equipment such as air-ride vans or flatbeds, do not ship via the LTL carriers listed in this guide. Contact Lincoln’s Inbound Logistics @ [Kyle.Morris@lincolnelectric.com](mailto:Kyle.Morris@lincolnelectric.com) for routing assistance.

3. Steel Suppliers

If your company supplies Lincoln Electric with any type of steel requiring Prepaid transport via flatbeds, please continue to ship as usual until further notification.

4. Chemical Truckloads

Continue shipping truckload shipments of chemical as usual until further notification.

ANY SHIPMENT SENT TO US **COLLECT** VIA UNAPPROVED CARRIERS WILL BE BILLED TO THE VENDOR.
