

## LINCOLN ELECTRIC FREIGHT CARRIER GUIDE FOR INBOUND OHIO DOMESTIC SHIPMENTS

**All freight-related documentation — including Invoices and Bills of Lading (BOLs) — must include the corresponding Lincoln Electric Purchase Order (P.O.) Number.**

If you are approved by Lincoln Electric to ship using your own carrier, please continue to do so.

Otherwise, ship **Collect** via UPS ground or the appropriate LTL carrier as outlined in the attached Routing Guide.

**Do not ship Prepaid and add freight charges to your invoice unless you have prior approval from Lincoln Electric.**

Shipment Information needed: Ship From / Ship To name and address, pallet count, weight and dimensions of each pallet, required truck equipment, shipping instructions, first available pick-up and delivery dates.

### **UPS Ground Shipments:**

1. Ship UPS **Collect**. Refer to the UPS account number located on our P.O.
2. If you do not have your own UPS account, you cannot ship UPS collect. Contact Lincoln's Inbound Logistics Team.
3. Use UPS from all states for shipments **1 to 70lbs.** total gross shipment weight.
4. High Dollar Value items should be insured when shipping via UPS. Call your Lincoln Electric Buyer for guidelines.
5. **Do Not Ship** multiple packages via UPS if the total gross weight exceeds 70 lbs. for all packages combined.
6. **Do Not Ship hazardous shipments via UPS. Use the appropriate LTL carrier outlined in Routing Guide below.**

### **LTL Shipments Under 10,000 lbs.:**

1. Locate the State you are shipping from on Routing Guide and contact the appropriate carrier for pickup.
2. Ship **Collect** using an LTL Carrier listed on Routing Guide below for shipments **70 lbs. to 9,999 lbs.**
3. **Exception#1** – Freight weight > 10k lbs. **or** more than 1/2 of Trailer. **(Contact Lincoln's Inbound Logistics Team)**
4. **Exception#2** – Freight weight < 10k lbs. **and** 1/3, 1/2, or Full Trailer **(Contact Lincoln's Inbound Logistics Team)**
5. **Exception#3** – Freight falls into LTL Class: 400, 300, 250, 150, or 125. **(Contact Lincoln's Inbound Logistics Team)**

### **Air Freight: If instructed by Lincoln Electric to ship via Air Freight, use the following guidelines:**

1. Shipments **0 lbs. to 70 lbs.**, ship **Collect** via UPS Next Day Air. Refer to the UPS account number listed on our P.O.
2. Shipments **71+ lbs.**, please contact Lincoln's Inbound Logistics Team.

### **Third-Party Shipments: MUST BE APPROVED BY LINCOLN**

1. **Exceptions: BUYER APPROVED** - If a Lincoln Electric buyer has agreed to cover freight charges for shipments from your supplier to you, or from you to another supplier, please bill Lincoln Electric as third party—enter on Bill of Lading: **"Bill To: Lincoln Electric % Data 2 Logistics, PO Box 61050, Ft. Myers, FL 33906"**.
2. **Special Equipment Needs:** If the material shipped to Lincoln requires equipment such as air-ride vans or flatbeds, do not ship via LTL carrier. Contact Lincoln's Inbound Logistics Team.
3. **Steel Suppliers:** If your company supplies Lincoln Electric with any type of **Steel** that requires **Prepaid** transport via flatbed, please continue shipping as usual until further notice.
4. **Chemical Truckloads:** Continue shipping truckload chemical shipments as usual until further notice.
