TERMS and CONDITIONS of SALE

DEFINITIONS

定义

- A. **Assemble-To-Order** “(ATO)” means any Material requiring pre-sale assembly.
按订单装配 “(ATO)” 系指需要售前组装的任何材料。
- B. **“Buyer”** or **“Customer”** means the person or entity that has acquired, or will be acquiring the Goods. Buyer or Customer may also possibly be the End User as defined below.
“买方” 或 “客户” 系指已取得或将要取得产品的个人或实体。买方或客户也可为下述定义中的最终用户。
- C. **“Consumables”** means any Material that is consumed within the electric-arc welding process including but not limited to welding wire both flux-cored and solid; flux; and stick electrode, both flux-coated and bare. Consumables may include MTO, MTS, WIP and Raw Materials.
“焊材” 系指在电弧焊接过程中消耗的材料，包括但不限于药芯焊丝和实芯焊丝、焊剂、以及涂药焊条和裸露焊条。焊材可包括MTO、MTS、WIP 和原材料。
- D. **“End User”** means the person or entity that purchases Products directly from Lincoln China or a Lincoln China Authorized Distributor for the use by such third party and not for resale.
“最终用户” 系指为使用且不转售之目的直接从林肯中国或林肯中国授权经销商购买商品的个人或实体。
- E. **“Large Quantities”** means any quantity that Lincoln China, in its sole discretion, deems to be excessively large and requiring special procedures, cancellation policies and pricing.
“大批量” 系指任何由林肯中国自行决定视为数量巨大，并且须经特别的程序、取消政策和定价处理的数量。
- F. **“Goods”** unless the context specifies otherwise, means any saleable item. Can be used interchangeably with “Materials” or “Products.”
“产品” 除本文另行说明外，系指任何可供出售的物品，可与“材料”或“商品”交替使用。
- G. **“Incoterms® 2010”** means the 2010 version of the International Commercial Terms as promulgated by the International Chamber of Commerce.

“国际贸易术语解释通则®2010”系指国际商会发布的 2010 版国际贸易术语。

H. “**Lincoln China**” or “**Seller**” means any of the following entities as enumerated in a Sales Order as defined in these Terms and Conditions. Only those entities listed below and specifically denoted in a Sales Order, along with the Buyer, will be considered a party to a Sales Order. Nothing in these Terms and Conditions shall be construed to make any of the entities below, liable in any way whether jointly or severally, for a Sales Order to which it is not a specifically-enumerated party.

“**林肯中国**”或“**卖方**”系指于该等条款和条件中定义的任何在销售订单列出的下述实体。只有于下文所列并于销售订单中明确指出的实体与买方将被视为销售订单的一方。如下述任一实体并非某一特定销售订单的一方，该等条款和条件均不得解释为，该实体以任何方式共同或连带地对该等销售订单承担责任。

I. **Made-To-Order “(MTO)”** means Materials that are manufactured to individual Customer specifications. Sales Order quantities may be shipped and invoiced with up to a 10% manufacturing over-run.

定制“**(MTO)**”系指根据客户的单独规格要求制造的材料。销售订单下产品可按照至多超过制造量的 10%的数量进行发货并收取价款。

- J. **Make-To-Stock “(MTS)”** means Materials that are standard, pre-made Materials that are stocked by Lincoln China in the ordinary course of business as it is defined by Lincoln China.
存货生产 “（MTS）” 系指按照林肯中国定义的，在林肯中国日常经营过程中库存的标准的预制材料。
- K. **“Material(s)”** means any saleable item. Can be used interchangeably with “Goods” or “Products.”
“材料” 系指任何可供出售的物品，可与“产品”或“商品”交替使用。
- L. **“Price”** means the amount charged by Lincoln China to the Buyer for Goods and Services rendered as further outlined in these Terms and Conditions with final Price being determined at time of shipment.
“价格” 系指林肯中国因其提供的产品和服务（该等条款与条件中将作进一步概述）而向买方收取的金额，其最终价格将以林肯中国发货时的定价为准。
- M. **“Products”** means any saleable item. Can be used interchangeably with “Materials” or “Goods.”
“商品” 系指任何可供出售的物品，可与“材料”或“产品”交替使用。
- N. **“Purchase Order”** means any offer by Buyer to Lincoln China to purchase Goods. Certain specifics of Purchase Orders may be accepted by Lincoln China by preparation of a Sales Order. All other terms and conditions of the Buyer’s Purchase Order, not included in the Sales Order, are expressly disclaimed.
“采购订单” 系指买方向林肯中国发出的购买产品的任何要约。林肯中国可以通过制备销售订单而接受采购订单中的部分规定。买方采购订单中的其他所有未被包括在销售订单中的条款和条件，均为卖方明确拒绝的条款和条件。
- O. **“Raw Materials”** means any basic or constituent material from which a Product is made.
“原材料” 系指用于制造商品的任何基础材料或构成材料。
- P. **“Sales Order”** means an acknowledgement generated by Lincoln China that authorizes the sale of Goods after receipt of a Customer’s Purchase Order pursuant to specifics as agreed by Lincoln China.
“销售订单” 系指林肯中国收到客户的采购订单后根据林肯中国所同意的条款制作的授权出售产品的一份订单确认单。
- Q. **“Services”** means all services supplied by Lincoln China to the Buyer and possibly includes delivery and installation of Goods.
“服务” 系指林肯中国向买方提供的所有服务，可能包括产品的运送和安装。

R. **“Special Orders”** means any orders of Large Quantities of Materials or Materials requiring modification driven by specific Customer requirements. These requirements may include but are not limited to: specific testing requirements, unique packaging, lot control, calibration, or non-standard specifications or formulations as defined by Lincoln China.

“特殊订单”系指大批量材料的任何订单或需要根据客户具体要求进行改造的材料任何订单。该等要求可包括但不限于：具体的测试要求、特殊包装、批号控制、校准或非林肯中国定义的非标准规格或配方。

S. **“Welding Equipment”** means machines, apparatus, and parts required for the fabrication of welded articles.

“焊接设备”系指机械、装置和制造焊接物品所需的部件。

T. **Work in Process “(WIP)”** refers to all unfinished Lincoln China Materials that are at various stages of the production process.

半成品“（WIP）”系指处于生产过程各个阶段的所有未完成的林肯中国的材料。

GENERAL CONDITIONS

一般条件

All sales of Goods by Lincoln China are governed by Lincoln China’s current Terms and Conditions of Sale (**“Terms and Conditions”**). For sales to be considered to be exports by the government authorities of the People’s Republic of China, special terms and conditions covering payment, freight, insurance, forwarding and other matters related to foreign sales may be required by Lincoln China, from time to time, in Lincoln China’s sole discretion.

林肯中国所有产品的销售受林肯中国现行的销售条款和条件之约束（“条款和条件”）。对于中华人民共和国政府部门视为出口的销售，林肯中国可不时自行决定要求包括付款、运费、保险、转运和其他关于海外销售事项的特别条款和条件。

Unless otherwise agreed in writing by Lincoln China, these Terms and Conditions may not be waived or modified. Neither Lincoln China’s acknowledgement of a Purchase Order nor Lincoln China’s failure to object to conflicting, contrary, or additional conditions in a Purchase Order shall be deemed an acceptance of such conditions or a waiver of the provisions hereof.

除林肯中国另行书面同意外，该等条款和条件不得被放弃或修改。林肯中国对某一采购订单的认可，或未对某一采购订单中的矛盾、冲突之处或附加条件提出反对意见，均不应被视为林肯中国对该等条件的接受或对本条款和条件中规定的放弃。

All Terms and Conditions are subject to change by Lincoln China, from time to time, in Lincoln China’s sole discretion. Any changes or amendments to Terms and Conditions shall become effective on the date the updated Terms and Conditions are published on Lincoln China’s website at <http://www.lincolnelectric.com.cn/>. Lincoln China shall not be obligated to notify any Buyer separately of any changes, amendments or updates to Terms and Conditions notwithstanding conflicting language found in any other agreement or terms and conditions.

所有条款和条件均受林肯中国不时自行决定作出的变更的管制。任何对于该等条款和条件的变更或修改应于该等变更或修改作出并于林肯中国的网站 (<http://www.lincolnelectric.com.cn/>) 更新之日起生效。林肯中国无义务单独通知任何买方该等条款和条件的任何变更、修改或更新，无论是否在其他协议或条款和条件中有冲突的语言描述。

PRICES **价格**

The Prices for Goods shall be established by Lincoln China and communicated, from time to time, at the sole discretion and in the format desired by Lincoln China. Lincoln China reserves the right to change Prices at any time without notice notwithstanding conflicting language found in any other agreement or terms and conditions. All Purchase Orders are subject to final acceptance by Lincoln China. Final acceptance will occur in a manner designated by- and at the sole discretion of Lincoln China.

林肯中国有权不时地自行决定通过其希望的形式发布、传达产品价格。无论是否在其他协议或条款和条件中有冲突的语言描述，林肯中国保留其在不发送通知的情况下随时变更价格的权利。所有的采购订单以林肯中国最终接受为准。最终接受的表现形式以林肯中国自行决定和发出的形式为准。

- **Final Price for all Goods will be in effect at the time of shipment by Lincoln China.**
- 所有产品的最终价格为林肯中国发货时的有效价格为准。

Buyer shall contact Lincoln China's Sales Department for Prices of Large Quantities of Materials, ATO, MTO items and/or Special Orders designed or manufactured at the Buyer's request.

对于大批量材料的价格、ATO、MTO 物品和/或根据买方要求设计或制造的特殊订单的价格，买方应联系林肯中国的销售部门进行了解。

Prices include charges for Lincoln China's standard packaging. All other charges are at the Buyer's expense unless agreed in writing by Lincoln China. All inquiries regarding additional charges are to be directed to Lincoln China's Sales Department.

价格包括林肯中国的标准包装费用。除林肯中国另行书面同意外，其他所有费用均由买方承担。所有关于额外费用的询问应向林肯中国销售部门进行。

Prices are inclusive of taxes/duties, and all prices are subject to additional taxes/duties payable or charged by Lincoln China at any time as required by law for the sale, purchase, lease, loan, or use of the goods.

价格包括税收/关税，并且所有价格受制于任何时候法律要求林肯中国因出售、购买、租赁、贷款或商品使用而支付或收取的额外的税收/关税。

Minimum Sales Order amount shall equal or exceed 1,000 RMB unless otherwise agreed in writing by Lincoln China.

除林肯中国另行书面同意外，销售订单最低金额应等于或大于 1000 元人民币。

PAYMENT

付款

In general, payment is due to be received by Lincoln China net thirty (30) days from shipment date with pre-approved credit in place; no cash discounts allowed unless otherwise agreed in writing by Lincoln China.

一般情况下，在林肯中国预先核准了信用的情况下，林肯中国应于装运日起三十（30）日内收到价款；除林肯中国另行书面同意外，否则不允许现金折扣。

In particular, payment for Goods which represent Large Quantities of Materials; ATO; MTO items; and/or Special Orders designed or manufactured at the Buyer's request, are based on terms of 30% of Price due at time of Buyer's receipt of Sales Order and 70% of Price due net thirty (30) days after shipment date with pre-approved credit in place; no cash discounts allowed unless otherwise agreed in writing by Lincoln China. The ordered Goods shall not be manufactured until the initial payment (30% of Price) is received and cleared.

特殊情况下，对于大批量材料、ATO、MTO 物品、和/或根据买方要求设计或制造的特殊订单的价款按照如下期限支付：买方收到销售订单前应支付价格的30%，装运日后三十（30）日内应支付剩余70%的价格（在林肯中国预先核准了信用的情况下）；除林肯中国另行书面同意外，否则不允许现金折扣。在收到并结清首期付款（价格的 30%）前，不制造订购的产品。

TRANSPORTATION AND DELIVERY

运输和交付

General **普通条款**

Unless otherwise stipulated, all Terms of Delivery shall be per **Incoterms® 2010**.

除非另行规定，所有交付条款应按照国际贸易术语解释通则®2010 的规定进行。

Sales Orders will ship automatically and without confirmation by the Buyer, unless otherwise agreed by Lincoln China. All Sales Orders will ship on or near the Buyer's requested ship date depending on type of Material ordered and overall Material availability. Lincoln China shall use reasonable efforts to initiate shipment as close as possible to the Buyer's requested ship dates.

除林肯中国另行同意外，销售订单项下的产品或商品等将进行自动装运而不需买方确认。所有销售订单下材料将根据订购的材料类型和材料的整体库存情况于买方要求的发货日期当日或该日期前后发货。林肯中国应尽合理努力，尽可能于接近买方要求的发货日期发货。

THE BUYER ACKNOWLEDGES THAT SHIP DATES PROVIDED BY LINCOLN CHINA ARE ESTIMATES ONLY AND THAT LINCOLN CHINA IS NOT LIABLE FOR FAILURE TO SHIP ON SUCH DATES.

买方认可林肯中国提供的发货日期仅为预估的日期；若未于该日发货，林肯中国将并不因此而 承担任何责任。

Transportation and Handling Expenses **运输和装卸费用**

For Domestic Sales Orders:
国内销售订单:

In general, Seller will provide standard transportation and handling of the Goods for delivery to Buyer's domestic "Ship-To" location at no additional cost using Seller's preferred transportation carriers and Seller's standard packaging. Seller reserves the right to add transportation and handling costs to Buyer's invoice if Buyer does not utilize one of Seller's preferred transportation carriers, requires additional packaging of the Goods and/or has other special delivery requirements. Transportation and handling costs will be added to Buyer's invoice for Sales Orders below established quantity as stated in the LE China published price list. A freight allowance may be available for Customers who arrange for, and execute, freight pick-up of their full order at the shipping point designated by Lincoln China. The allowance will be determined by Lincoln China Customer Care and, once determined, is final and non-negotiable.

一般情况下，卖方将使用其首选的承运人和其标准包装以提供标准运输和装卸服务将产品运送至买方国内的“交货地”地点，卖方对此不收取额外费用。若买方不使用卖方首选的任一承运人要求额外的产品包装和/或其他特殊的运送要求，则卖方有权在买方的账单中增加运输和装卸费用。运输和装卸费用将添加至买方相应销售订单的账单中，对于数量低于林肯价格表规定的最低数量。若客户于林肯中国指定的装运地点安排并提取其订购的所有货物，则可享受运费补贴。具体补贴的情况将由林肯中国客户服务部决定。一旦决定，该等补贴将为最终且不可协商的。

For International Sales Orders:
国际销售订单:

All transportation and handling charges for the Goods shall be at the Buyer's expense and shall be added to the commercial invoice. There will be no allowance or deduction to the selling Price for the pick-up of Sales Orders at the shipping point as designated by Lincoln China by the Customer's appointed carrier. Appropriate Value-Added Taxes ("VAT") will be calculated based on Materials, transportation and handling charges as set forth on the commercial invoice.

所有产品的运输和装卸费用应由买方承担并应添加至其商业账单中。客户指定的承运人于林肯中国指定的装运地点提取销售订单下产品或商品的将不能获得销售价格的扣减或津贴。适当的增值税（“**增值税**”）将根据商业账单上载明的材料、运输和装卸费用来计算。

All additional charges, other than transportation and handling expenses, including but not limited to: Customs Broker and Freight Forwarder fees, warehouse and terminal charges, insurance, inspection, storage, special notifications, special equipment/handling will be at the Buyer's expense unless otherwise agreed in writing by Lincoln China. Any such expenses may be separately invoiced to Buyer.

除经肯中国另行书面同意外，除运输和装卸费用外，所有额外费用（包括但不限于：海关经纪人和货运代理人费用、仓库和码头费用、保险、检查、储存、特别通知、专用设备/装卸费用）将由买方承担。卖方可就任何该等费用另行向买方发送账单。

TRANSFER OF TITLE **所有权转移**

Unless otherwise agreed by Lincoln China, title to the Goods shall transfer to Buyer when full payment is received and cleared by Lincoln China. Ownership of the Goods shall remain with Lincoln China, which reserves the right to dispose of the Goods until such time as:

除林肯中国另行同意外，产品所有权应于林肯中国收到并结清所有价款时转移至买方。林肯中国保留产品所有权，其同时保留处置产品的权利，直至下述时间：

- Payment in full for all the Goods has been received and cleared; or
所有产品的价款已经全额收讫并结清；或
- The Buyer sells the Goods to its customers in the ordinary course of business.
买方在日常经营过程中将产品出售给其客户。

If the Buyer fails to pay any amount of the Buyer's total indebtedness to Lincoln China when it is due, or breaches any of these Terms and Conditions, Lincoln China may, without prejudice to any of its other rights and remedies, recover and/or re-sell the Goods, or any of them, and may enter upon the Buyer's premises for that purpose.

若买方未付清其对林肯中国全部到期欠款的任何部分，或违反任何该等条款和条件，在不损害林肯中国其他权利和救济的情况下，林肯中国可收回和/或再次出售产品（或其中的任何部分产品），并可为该目的进入买方的经营场所。

Until full payment is received by Lincoln China, the Buyer shall store the Goods in a way that clearly indicates Lincoln China's title to the Goods.

直至林肯中国收到全额付款，买方应以一种可以明确显示产品所有权归林肯中国所有的方式储存产品。

The Buyer acknowledges that until its total indebtedness to Lincoln China is discharged, it holds the Goods as bailee for Lincoln China and that a fiduciary relationship exists between them.

买方认可，其以受托者身份为林肯中国持有产品直至其缴清对林肯中国的欠款总额，并且双方之间存在信托关系。

In the event of sale of the Goods to the Buyer's customer, the Buyer in its position as a fiduciary shall:

向买方的客户出售产品时，买方作为受托人应：

1. Assign to Lincoln China the benefit of any claim against the Buyer's customer, and;
将任何针对买方客户主张的利益转让给林肯中国，和；
2. Account fully to Lincoln China for the proceeds of the sale unless and until the Buyer's total indebtedness to Lincoln China is discharged.
就销售收入向林肯中国报账直至买方缴清对林肯中国的全部欠款。

TRANSFER OF RISKS

风险转移

Risk of loss of the Goods shall pass to the Buyer upon tender to the first transportation carrier unless a specific Incoterm, as found in Incoterms 2010®, is agreed by Lincoln China and documented in the Sales Order.

除非林肯中国同意使用 2010 年国际贸易术语解释通则中的某一特定国际贸易术语并且将其记录于销售订单中，否则产品灭失的风险应于产品交给第一承运人时转移至买方。

INTELLECTUAL PROPERTY OWNERSHIP AND LICENSES

知识产权归属和许可

Retention of Ownership. Except for the rights expressly granted to the Buyer, the Seller will retain all right, title and interest to all worldwide technology, software and intellectual property (the “**Intellectual Property**”) and proprietary rights of the Goods and associated software.

所有权保留。除明确授予买方的权利外，卖方将保留所有对于全球技术、软件和知识产权的权利、所有权和利益（“**知识产权**”）以及产品和相关软件的专有权利。

Preservation of Notice. Buyer shall not remove, efface or obscure any copyright notices or other proprietary notices or legends from any of the Goods and shall reproduce all such notices and legends when incorporating the Goods into any subsequent Products.

声明保存。买方不得移除、抹去或隐藏任何产品上的任何版权声明或其他专属声明或标记，并应在将产品装入任何后续商品时重制所有该等声明和说明。

Notice of Intellectual Property Infringement. The Buyer shall promptly notify the Seller in writing of any unauthorized use of any Intellectual Property of which the Buyer becomes aware. The Seller shall have the exclusive right, in its sole discretion, to institute any proceedings against such third party in its name and on its behalf. The Buyer shall render the Seller full support as the Seller deems necessary. Such support shall include, but not be limited to, submission to the Seller of any documentation or joining the proceedings as one Party at the Seller’s request to support the Seller’s claims. The Seller shall be responsible for the reasonable costs as may be incurred on the part of the Buyer in rendering such support unless such proceedings arise from any breach by the Buyer of any provisions of these Terms and Conditions. All recoveries from such claims or actions shall be the sole and exclusive property of the Seller.

知识产权侵权通知。买方若知晓任何未经授权使用知识产权的情形应立即书面通知卖方。卖方应有独占权利自行决定以其自身名义并代表自己提起任何对抗该等第三方的诉讼。买方应向卖方提供卖方认为必要的全力支持。该等支持应包括但不限于，向卖方提交任何书面文件或根据卖方要求作为一方参加诉讼以支持卖方的主张。除非该诉讼是由于买方违反任何该等条款和条款的规定而引起的，否则卖方应承担买方为提供该等支持而发生的合理费用。由该等主张或诉讼获得的所有赔偿应为卖方独有和专有的财产。

SPECIAL ORDERS

特殊订单

Special Orders means any orders of Materials requiring modification driven by specific Customer requirements. These requirements may include but are not limited to: specific testing requirements, unique packaging, lot control, calibration, or non-standard specifications or formulations as defined by Lincoln China.

特殊订单系指需要根据客户具体要求进行改造的材料任何订单。该等要求可包括但不限于：具体测试要求、特殊包装、批号控制、校准或林肯中国定义的非标准规格或配方。

Special Order quantities for Consumables may be shipped and invoiced with up to a 10% manufacturing quantity overage.

焊材的特殊订单订货量可按照至多超过制造数量的 10%的数量进行发送并收取价款。

Normal shipping lead time for Special Orders is within four (4) weeks of Sales Order creation, contingent upon the availability of Raw Materials and Customer specification. Special Orders may carry an extended delivery time. Buyer shall contact Lincoln China's Sales Department for lead times and other specifics. If expedited delivery is required, additional charges may apply at Lincoln China's sole discretion and at the expense of the Buyer.

特殊订单通常的交付期为销售订单生成后四（4）周内，视原材料的库存情况和订货规格而定。特殊订单可延长交付时间。关于交付期和其他详情买方应联系林肯中国销售部门。若要求加速交付，林肯中国可自行决定由买方承担额外的费用。

CANCELLATION OF ORDERS

取消订单

Made To Stock (MTS) Items

按库存生产（MTS）物品

Orders for MTS Goods not designated as Large Quantities may be cancellable without charge provided the Buyer notifies the Lincoln China Customer Care Department in writing requesting cancellation prior to the tender of the Goods to the first transportation carrier or pick-up by the Buyer at the designated Lincoln China facility.

若买方在产品交给第一承运人之前，或买方于指定的林肯中国工厂提货之前，书面通知林肯中国客户服务部要求取消订单，则未按大批量订购的MTS 产品的订单可免费取消。

ATO, MTO, Large Quantities of Materials and Special Orders designed or manufactured at the Buyer's request, are **NON-CANCELLABLE**. If Buyer attempts cancellation of the aforementioned Goods, the Buyer shall be responsible to pay the full Price for the Goods, less any advance payments, with remaining balance due to be received by Lincoln China net thirty (30) days from invoice date.

ATO、MTO、大批量材料和按照买方要求设计制造的特殊订单**不可取消**。若买方希望取消上述产品的订单，则自发票日期起三十（30）日内，买方应向林肯中国支付扣除任何预付款后的产品的全部价格。

RETURN OF UNUSED GOODS

退回未使用产品

Lincoln China, may, at its sole and absolute discretion, accept unused Materials for return from the Buyer. Unused Material will be considered for return only for credit to the Buyer's account as outlined in these Terms and Conditions. All Material considered for return must be MTS Goods and shall not be designated Large Quantity, as determined at Lincoln China's sole discretion.

林肯中国可完全自行决定是否接受买方退回的未使用过的材料。对于拟退回的未使用材料，林肯中国只将相应信用额度退回于该等条款与条件中规定的买方的账户中。所有拟退回的材料必须为 MTS 产品并且不得为指定的大批量（由林肯中国自行决定）。

Sales of ATO and MTO Goods and Special Orders designed or manufactured at the Buyer's request; all discontinued Goods and Large Quantities of Materials; as well as all engine-drive welders are **FINAL and NON-RETURNABLE**.

ATO 和 MTO 产品和按照买方要求设计或制造的特殊订单、所有停产的产品和大批量材料、以及所有机动焊机的销售为不可更改的且不可退货的。

Conditions of Return

退货条件

The Goods must be unused, undamaged and in original packaging. Packaging of software and printed circuit boards must be unopened.

产品必须未经使用、未遭损坏并置于原包装中。软件和线路板电镀的包装须为未开封。

Freight Charges of Returned Goods

退货运费

Buyer shall be responsible for delivering any Goods authorized for return, at their sole expense and risk, to a facility designated by Lincoln China.

客户承认并同意，由林肯中国披露或客户因与林肯中国的关系或通过该种关系而口头或书面获悉的但仍未为公众所知悉的所有文件（除广告宣传材料和用户信息外）和保密商业信息，无论以任何形式或媒介，包括但不限于有关林肯中国产品、财务、流程和服务、客户、购买、临床试验、试验结果、工程技术和技术、会计、生产、分销和营销的信息（以下简称“**信息**”），应视为林肯中国独有和专属的财产；客户应对此严格保密；且除明确许可外，客户不得将信息进行发表、披露、传播或以任何方式进行使用。客户不得对信息进行全部或部分复写或复制，且在交易和/或销售/购买关系到期或终止之时必须归还或销毁该等信息。此外，客户应当保护该等信息并确保只有为履行与交易相关的客户义务而需要访问该等信息的雇员、管理人员和董事才可获悉该等信息。所有该等雇员、管理人员和董事应遵守此保密条款和不得使用信息的义务。

FORCE MAJEURE

不可抗力

Lincoln China shall not be in default for failure to perform and shall not be liable for loss, damage, detention or delay when prevented from doing so by causes beyond its reasonable control including but not limited to acts of war (declared or undeclared), Acts of God, fire, terrorism, sabotage, power, explosions, epidemics, pandemics, civil disturbances, strike, labor difficulties, acts or omissions of any governmental authority, compliance with government laws or regulations, insurrection or riot, embargo, delays or shortages in transportation or inability to obtain necessary labor, raw materials, supplies, equipment or power in sufficient amounts or at reasonable prices including as a result of any governmental action or policies (including tariffs or customs), or equipment failure, or from defects or delays in the performance of its suppliers or subcontractors due to any of the foregoing enumerated causes (collectively hereinafter the "**Force Majeure Event**").

林肯中国因超出其合理控制范围的原因而未能履行义务，不应视为违约，也不应对因此造成的损失、损害、扣押或延误负责。这些原因包括但不限于战争行为（已宣战或未宣战）、天灾、火灾、

恐怖主义、破坏、电力、爆炸、流行病、疫情、内乱、罢工、劳工困难、任何政府当局的行为或不作为、遵守政府法律或法规、叛乱或暴动、禁运、运输延误或短缺、无法获得必要的劳动力、原材料、供应品、设备或电力，包括因任何政府行动或政策（包括关税或海关）导致的合理数量或价格不足、设备故障，或因上述任何原因导致的供应商或分包商的缺陷或延误（统称为“不可抗力事件”）。

If any such Force Majeure Event prevents the Lincoln China's performance of any of its obligations under a Sales Order, Lincoln China shall have the right to (a) terminate or cancel the Sales Order or (b) omit during the period of the Force Majeure Event all or any portion of the quantity of the goods/services deliverable during that period, whereupon the total quantity deliverable under the particular Sales Order shall be reduced by the quantity omitted. Upon the occurrence of any Force Majeure Event or circumstance referenced above and in case Lincoln China is unable to supply the total demands for any Goods to be delivered under a Sales Order, Lincoln China shall have the right to allocate goods, services and/or software among its customers in its sole discretion. This clause supplements, and does not replace, any remedies available to Lincoln China under applicable law. For the avoidance of doubt, no change, cancellation or allocation by Lincoln China shall be deemed to be a breach of any provision, term, condition, or covenant of a Sales Order or an agreement.

如果任何此类不可抗力事件阻止林肯中国履行其在销售订单下的任何义务，林肯中国有权(a) 终止或取消销售订单，或(b) 在不可抗力事件期间省略在该期间可交付的全部或任何部分货物/服务的数量，从而特定销售订单下的总可交付数量将减少省略的数量。在发生上述任何不可抗力事件或情况时，如果林肯中国无法供应销售订单下任何货物的全部需求，林肯中国有权自行决定在其客户之间分配货物、服务和/或软件。本条款补充并不替代林肯中国根据适用法律可获得的任何补救措施。为避免疑义，林肯中国的任何变更、取消或分配均不应视为违反任何销售订单或协议的任何条款、条件或契约。

COMPLIANCE WITH LAWS

合规

Buyer shall comply with all applicable laws and regulations with respect to the business conducted with Lincoln China, including (without limitation) all applicable U.S. and other “Anti-bribery Laws,” which prohibit the payment or transfer directly or indirectly of anything of value to governments, government officials, state-owned enterprises, political parties, political party officials, or to relatives or associates of such officials, in connection with obtaining or maintaining business or an improper business advantage. 买方在与林肯中国进行商业交易时应当遵守一切适用的法律法规，包括（但不限于）所有适用的美国和其他国家和地区规定禁止为获得或维护经营或不正当商业优势，直接或间接向政府、政府官员、国有企业、政党组织、政党官员、或以上人员的亲属或关联人支付或转让任何有价值的物品的反贿赂法。

Buyer agrees that it will not participate in the sale of Lincoln Products or technology to any entity in or for export to any country that is deemed to be a “prohibited country” under U.S. export control laws (currently, Cuba, Iran, North Korea, Sudan or Syria) or for use in nuclear, chemical or biological weapons or rocket or missile applications.

买方同意其将不参与向任何国内实体销售林肯产品或技术，或将林肯产品或技术出口至任何被美国出口管制法认定为“禁止性国家”的国家（现阶段为古巴、伊朗、北朝鲜、苏丹或叙利亚）或将产品用于核应用、生化武器、火箭或导弹应用。

Upon Buyer's request, Seller shall provide information in response to any reasonable request regarding

compliance with applicable laws, rules or regulations.

根据买方的要求，卖方应提供遵守适用的法律、法规或规章的相关信息。

DISPUTES

争议解决

Any dispute or claim arising from or in connection with these Terms and Conditions and/or any Sales Orders, transactions, agreements, performance between Lincoln China and the Customer in relation to the sale, including, but not limited to any question regarding its existence, validity, interpretation or termination shall be settled amicably through friendly negotiation.

任何由该等条款和条件和/或林肯中国和客户之间的任何销售订单、交易、协议、履行（包括但不限于任何与存续、效力、解释或终止相关的问题）引起或与之相关的争议或索赔均应通过友好协商进行解决。

In the event that the Buyer is not located in the People's Republic of China, the dispute or claim shall be submitted to Shanghai International Economic and Trade Arbitration Commission/Shanghai International Arbitration Center for arbitration.

如果买方不是位于中华人民共和国境内，该等争议或索赔应提交上海国际经济贸易仲裁委员会/上海国际仲裁中心进行仲裁。

In the event that the Buyer is located in the People's Republic of China, the dispute or claim shall be resolved by the people's court where Lincoln China is located.

如果买方位于中华人民共和国境内，该等争议或索赔应提交至林肯中国所在地人民法院予以解决。

During the litigation or arbitration proceedings, these Terms and Conditions and/or any Sales Orders, transactions, agreements, performance between Lincoln China and the Buyer in relation to the sale shall remain in full force and effect in all aspects except for the matter under trial or arbitration. The Parties hereto shall continue to perform their obligations thereunder, except for those obligations that are under dispute.

In the event that any one or more of the provisions in these Terms and Conditions is deemed to be illegal, invalid or unenforceable in any respect under any applicable PRC law, the provision shall be deemed severed from the Terms and Conditions, and the validity, legality and enforceability of the remaining provisions contained herein shall not in any way be affected or impaired thereby. The Buyer and Lincoln

China further agree that a provision similar in terms to the aforesaid invalid, illegal or unenforceable provisions as may be legal, valid or enforceable shall be incorporated into the Terms and Conditions so that the intentions of the Parties hereto expressed herein may be accomplished to the fullest extent possible. 若该等条款和条件中任一条款或多个条款根据中华人民共和国现行法律被认定为非法、无效或不可执行，该等条款应从该等条款和条件中分离，剩余条款的效力、合法性和执行力均不受其影响。买方和林肯中国进一步同意，为使双方的意志得到充分体现，与上述无效、非法或不可执行的条款类似的但可能合法、有效或可执行的条款应当纳入该等条款和条件。

APPLICABLE LAW

法律适用

Unless otherwise outlined in these Terms and Conditions the interpretation and performance of these Terms and Conditions and the relevant Sales Orders, transactions, agreements, performance between Lincoln China and the Customer in relation to the sale shall be governed by the laws and regulations of the People's Republic of China.

MISCELLANEOUS

Relationship of the Parties. The Buyer shall be considered to be an independent contractor. The relationship shall not be construed to be that of employer and employee, nor to constitute a partnership, joint venture or agency of any kind. Unless otherwise specified under these Terms and Conditions, the Buyer agrees to pay, and shall solely bear, all of its incurred expenses in connection with these Terms and Conditions and/or any Sales Orders, transactions, agreements, performance between Lincoln China and the Buyer in relation to the sale, including without limitation all travel, lodging and entertainment expenses. The Buyer shall have no right to enter into any contracts or commitments in the name of, or on behalf of, Lincoln China, or to bind Lincoln China in any respect whatsoever.
