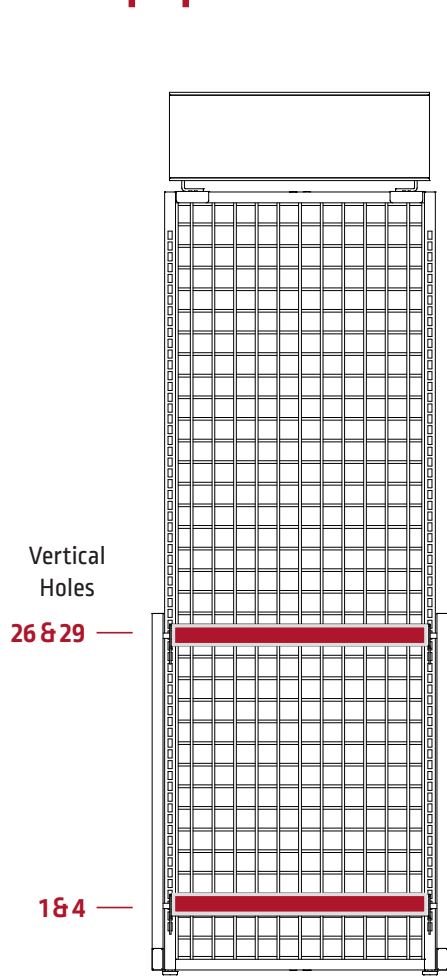


POINT OF PURCHASE DISPLAY PLAN-O-GRAM

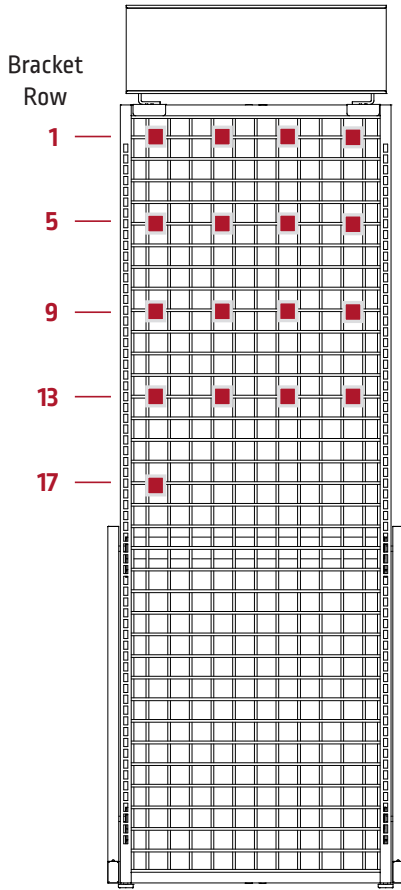

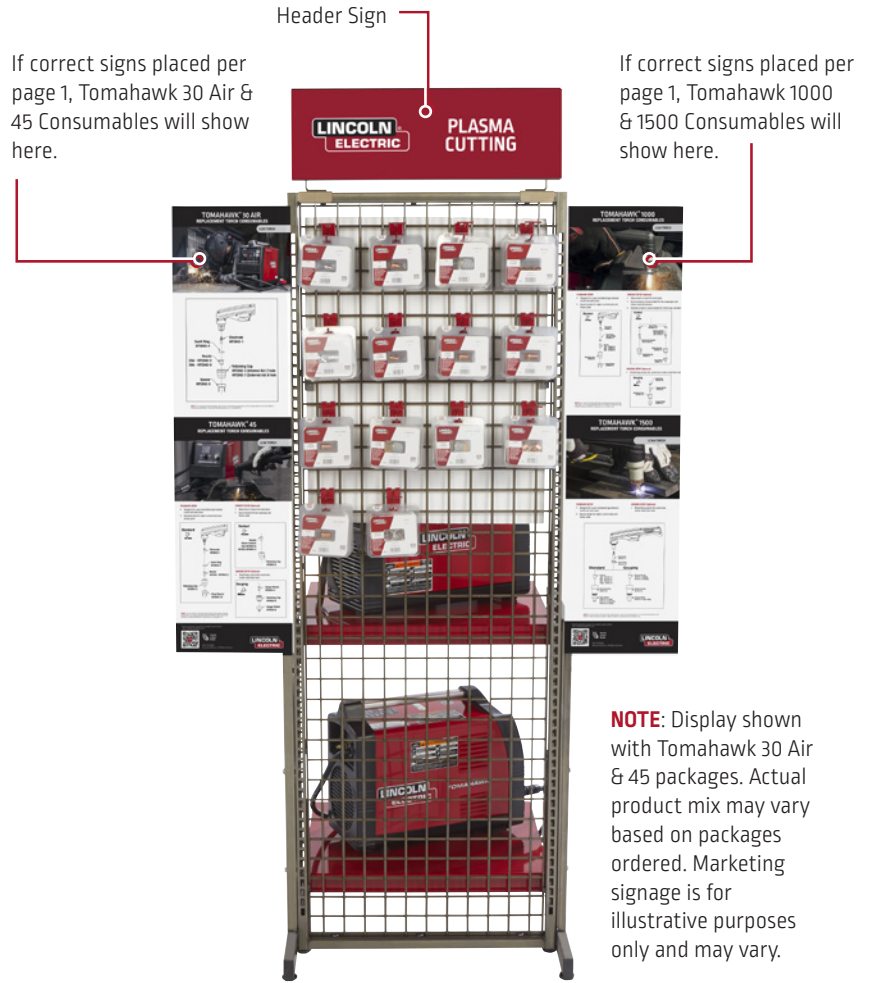

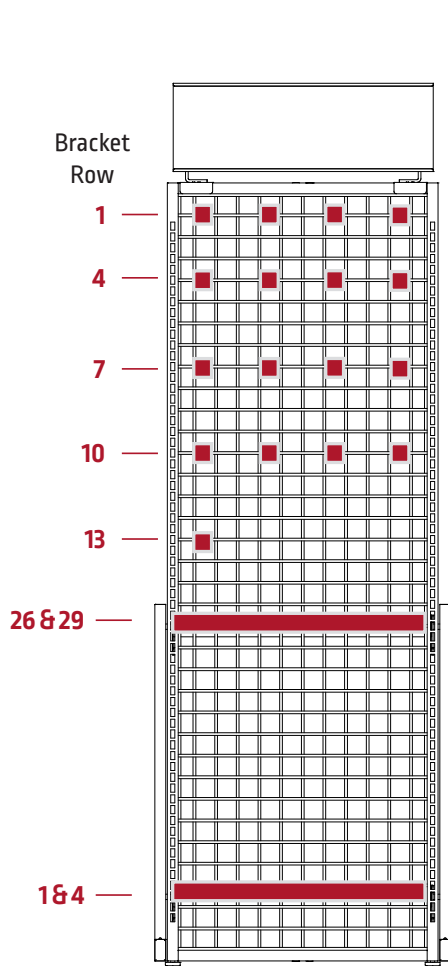
