#### **BRAZING PROPERTIES:**

Stay Silv 2LP is a lower phosphorus version of Stay Silv 2. The phosphorus reduction provides a wider melting range which improves the alloy's ability to fill non-uniform clearances.

## **CORROSION RESISTANCE**

Generally similar to the copper base metal, but phosphorus containing alloys, including Stay Silv 2LP, should not be used if the braze is exposed to sulfur or sulfur compounds in service
